Possible Motion/Discussion/Vote to approve submitting a Community Impact Statement regarding: **Senate Bill 9** – Relative to *proposed* California Government Code § 65852.21 in matters of two residential units within a single-family home defined as ministerial developments and not subject to discretionary review by a local agency. (5 minutes)
- VII. Possible Motion/Discussion/Vote to approve submitting a Community Impact Statement regarding: **Senate Bill 10** – Relative to *proposed* California Government Code § 65913.5 which allows a local government to pass an ordinance to zone a parcel for up to 10 units of residential density per parcel and in transit-rich areas. (5 minutes)
- VIII. Possible Discussion that the ANC Board consider **parking permit districts** in Arleta – Existing bus lines intersections and forthcoming Metro light-rail transit stations, both major transit stops, define a “transit-rich area” as *any parcel within a one-half mile of a major stop* as defined in California Public Resources Code § 21064.3. Proposed California state laws seek to override local control on parking. (5 minutes)
- IX. Possible Motion/Discussion/Vote to approve a Neighborhood Purpose Grant for up to \$5,000.00 in support of the Center for Assault Treatment Services (C.A.T.S.) for their 19<sup>th</sup> Annual Victory for Victims Walk/Run (5 minutes)

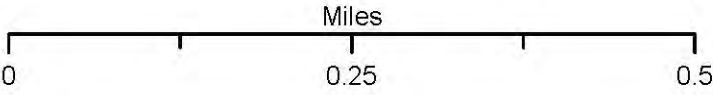


# Arleta: Parcels within Half-Mile of Proposed LRT Station

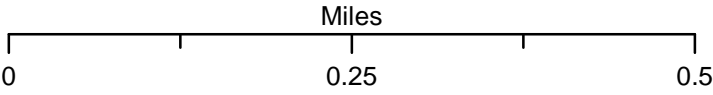
