- II. President’s Report** Please remain standing for a moment of silent memory for a former ANC Youth Representative and a former U.S. Marine, **Adrian Carrillo**, who died in a car accident here in Arleta in December;
And for **Joy Adkinson**, former Board Of Neighborhood Commissioners (BONC) Chairperson and an active advocate for programs to better the lives of people in our communities.
- III. Report from L.A.P.D. Senior Lead Officer and Fire Dept.**
LAFD Battalion 12 Chief, Scott Hilton. Located off Osborne, between San Fernando Rd. & Glenoaks, adjacent to Whiteman Airport. Our area Fire Department is better supported than many. The Fire Department gets a lot of calls for health-related problems. Our area now has a Paramedic Team with a Nurse Practitioner on-board. That person is knowledgeable and functions almost like having a doctor on the call with the team. There have been a lot of projects to clean up the washes.

- Jesse Leon, with L.A. METRO Community Leadership Council-** This council has representatives from each area. They are now recruiting for new members on the Council. Jan. 30th is the deadline for applying.
- Raymond Acevedo** represents a different agency within **METRO** than the previous speaker, Jesse Leon. Regarding the **ESFV Light Rail Transit Project** Quarterly Committee Meetings. There will be a presentation with L.A. DOT on Tuesday, Feb. 10th, 6:00-7:30 pm will be held on ZOOM. In-person version of that meeting and open house will be Thurs., Feb. 12th, 6:00-7:30 pm at the Alicia Broadus-Duncan Multipurpose Senior Community Center in Pacoima.. Plans are in the works to relocate Bike Lanes from Van Nuys Blvd.to be on Terra Bella St.. This will mean losing one lane of traffic each way (narrowing it down to 1 lane each way for automobiles) on Terra Bella. Fliers with details pertinent to these meetings are on the table.

- Dave Hunt (speaking as himself) – Petitions** for personal signatures for **Ballot Measures & Calif. Constitutional Amendment** on info table. **1. ID Required & to be a U.S. Citizen in order to VOTE.**
2. Reinforcing Proposition 13 with the intent as it was originally passed for limiting state and local measures to raise property taxes. Would **raise the limit back up to a 2/3 majority vote required to pass a property tax increase**, rather than the 50% + 1 threshold that has recently been pushed. Many petitions currently circulating at Walmart & the like seem to be good items to consider signing.

Discussion: Burton Hunter asked what was the \$1,500. Pending showing on both sets of documents.
Jesse Ramos answered that this is no longer pending; that its pending status has now been cleared (paid).

We passed a similar stated letter of intent in January of 2024 with a 2/3 majority vote under the previous guidelines of SB 411. **This is an update of that statement and acknowledging the new rules. It is required that it be submitted as a CIS.** Only a simple majority vote is required to pass this vote under these newly interpreted guidelines.

Discussion: Burton explained the basic content of the letter/ CIS.
Jose Galdamez, our NEA explained in brief, that this is a follow-up and update to SB 411. The SB 707 has guidelines and new rules, including new wording for NC Agendas when holding an all-virtual (“teleconferencing”) or that added accommodations are needed if holding a hybrid meeting (both in-person and allowing virtual attendees.) All must have accommodations for and be accessible to the public.
Some other guidelines for teleconferencing (virtual or virtual hybrid meetings) Check with the City Attorney’s Office for specific guidelines.
Upload the CIS to City Council File CF-23-1114.
Dave Hunt- Would any equipment we would need come out of our own budget? **A. Yes, paid for out of our own NC budget.** If hybrid (combined in-person & virtual), then a device of equipment is required for both locations to be able to be seen and heard.
