Claudia Mejia updated the current status of Cal-Trans projects in the area. Construction completion is currently at 75%. 8. <u>a.Discussion and possible board action on a presentation by DWP Groundwater</u> <u>Replenishment Project in Arleta. DWP representatives attending: John Hinds and</u> <u>Rosalba Santana</u>

Before John Hinds could make his presentation Mark Lopez and Luis E Sencion step out of the meeting at 7:08 citing a conflict of interest

90% of water supply in Los Angeles comes from outside Los Angeles. The DWP is working on a proposed plan to build an Advanced Water Purification Facility (AWPF) at the Tillman Water Reclamation Plant. This project is currently in its beginning stages and is projected to last until 2022. From the Tillman facility water would go into the Pacoima and Hansen Dam spreading grounds. The project is intended to reduce dependence on imported water supplies and increase groundwater supply. The department is currently conducting an environmental analysis.

Questions

<u>Stakeholder Miriam Fogler</u> expressed concern about flooding in the spreading grounds and the threat of mosquitoes. John Hines said LA County Flood Control is in charge of handling potential flooding issues.

<u>Board Member Jack Lindblad</u> asked about the extraction wells which have toxic plumes. J John Hines addressed that by saying as long as more stormwater and recycled water goes into the basin eventually the contaminant levels will go down. Nick Pierson asked how much would the water rates go up. John Hines said financing the project over a longer period of time will help decrease the overall impact on rates. They will look into state, local, and federal funding for help.

<u>Stakeholder Terry Hendricks</u> expressed concern with the pipeline going through Canterbury St because it is a major street. Asked if it was possible the pipeline go along the Pacoima wash instead of having to dig up a street. John Hines said he was not sure if that could be a possibility, but the department can look into it.

### **Public Comments:**

**Speaker:** <u>Miriam Fogler</u>-Urged everyone to get Van Nuys Video Conferencing to open so residents can express concerns to Council Members. It costs money to keep it open, but it is important to help the millions of citizens who are being affected by the proposed DWP project.

**Speaker:** <u>Donna Pearman</u> - Also concerned about Van Nuys Video Conferencing. She doesn't like going to downtown LA to speak with council members.

Jack Lindblad suggested all committees not meet in the same week, but be open to the possibility of back-to-back meetings until the end of the year. ## 10. Status of the Arleta Gateway Sign Project

Update on the status of the \$7,000 set aside by then Councilman Cardenas. Lorena Bernal informed the board that the money was spent by the Graffiti Buster to pay for the design. The money was originally intended to go towards the Arleta community and now Nuryøs office is looking where they the \$7,000 can come from.

James Kallas made a freedom of Information request to Sergio Ibarra and wants an update on the landscaping portion of the project. New CIC chair Maria Diaz has just come into the board and needs to be updated on the status of the sign and landscape. The sign company has been paid. There are additional permits to have the sign installed. New CIC chair Maria Diaz has just come into the board and needs has yet to receive information from previous CIC chair Jack Lindblad. Jack had sent out an e-mail to Maria with a pdf attachment titled õThe Declaration of Jack Lindblad. Maria said she would rather have met with Jack to discuss the information. The community improvement committee is to take up this item in the next CIC meeting on October 28 at Branford Child Care center at 6:30.

## 12. Board member comments on items not on today's agenda

**Speaker:** <u>Mark Lopez</u>- Attended a Community Development Department meeting at Pacoima City Hall. Homeless, economic development, and housing means were discussed topics.

**Speaker:** <u>Jack Lindblad</u>- There is a proposal to have trucks take 7 or 8 million cubic yards of sediment from Sylmar to Tujunga. This poses an environmental hazard. Sylmar residents are vocal against this proposed plan. He urges residents in Arleta, Sun Valley, Pacoima, and North Hollywood attend the upcoming hearing on October 19 and 22.

**Speaker:** James Kallas - The Treasurerøs report should still be presented by someone because the board has 10 days to submit a report or funding can be shut down. He asked the city attorney about special meetings and the fact that meetings can only go on with 1 or 2 items. The city attorney told him no, special meetings can go on with more than 2 items when Robert Rule say Special Meetings can only proceed with 2 items. The board does not operate under Robertø Rule but needs to.
