



# Meeting Minutes of the ARLETA NEIGHBORHOOD COUNCIL (ANC) GENERAL BOARD MEETING Tuesday, October 18, 2016

at Branford Park Child Care Center, 13310 Branford St., Arleta, CA 91331

ANC (and all other) Meeting Minutes are a summary; Minutes were not, are not and are never meant to be an exact, verbatim, word-for-word transcript or comprehensive record of what was said at a Meeting. Exceptions: Motions/Resolutions (as stated at the Meeting, which take precedence over versions written on the Agenda, if different); quotes (words that have quotation marks ("") at the beginning and ending of a word or words); and other wording from the Agenda such as the first paragraph(s) of some Items. Items are listed in and match the same order as on the Agenda.

#### I. Call to Order and Pledge of Allegiance

President John Hernandez called the Meeting to order at 6:33 p.m. The Pledge of Allegiance was led by Arleta High School Principal Casey Browne. Roll Call was taken by the Minutes Writer. Eight of the 11 Board Members were present at the Roll Call, which is not a quorum: Jesus Barron, Raymond Duran, Gary Gallon, John Hernandez (President), Loyce Lacson (Treasurer), Fernando Moreno, Ken Nguyen and Margaret Shoemaker (Secretary). Jaime Gallo arrived later. Daisy Chavez and Danna Gutierrez were absent. The ANC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is nine (see http://www.arletanc.org/wp-content/uploads/2015/09/ANC-Approved-Bylaws-090115SS.pdf), so at this time the Board could only take public comments and could not have any official discussions, and could not make any Motions or take any votes. In keeping with the ANC Bylaws, the Chair does not vote unless it affects the outcome. Eleven of the 17 Board Seats were filled (by election or appointment). Six Board Seats were vacant: At Large [Vanessa Lopez was appointed during below Item #X], Business, Renters (2), School, and Seniors; to apply, see www.ArletaNC.org. Also attended: 23 Stakeholders and Guests.

He explained that a transportation system was funded to facilitate travel to and from CSUN and reduce traffic, and encouraged supporting Measure M.

Mr. Browne noted the High School had "last year a 95.2% graduation rate . . . the highest in the San Fernando Valley . . . our attendance rate is 97%."

Ms. Lacson distributed copies of and reviewed the ANC "September Monthly Expenditure Report" and monthly Union Bank statement.

**FUNDING MOTION** (by Ms. Shoemaker, seconded by Mr. Gallo): The Arleta Neighborhood Council approves its September 2016 Monthly Expenditure Report.

**MOTION PASSED** unanimously by a roll call vote of eight of the nine eligible voters present with all eight in favor ("Yes" or "Aye") (Barron, Duran, Gallon, Gallon, Lacson, Moreno, Nguyen and Shoemaker; zero opposed; zero abstained.

- X. <u>Motion/Discussion/Vote</u> on a possible Board action to fill vacancies on the Arleta NC.
  - a. At Large Rep 1 Seat
     Mr. Hernandez read aloud the qualifications needed. Stakeholder Vanessa Lopez described her background and desire to serve.

**MOTION** (by Mr. Duran, seconded by Mr. Gallo): The Arleta Neighborhood Council appoints Stakeholder Vanessa Lopez to one of its At Large Board Seats.

**MOTION PASSED** unanimously by a roll call vote of eight of the nine eligible voters present with all eight in favor ("Yes" or "Aye") (Barron, Duran, Gallo, Gallon, Lacson, Moreno, Nguyen and Shoemaker; zero opposed; zero abstained.

New Board Member Vanessa Lopez was Seated at this time, making 10 Board Members present (the ANC quorum at this Meeting was nine).

  There were no candidates for the above Seats b.-e.; Mr. Hernandez encouraged applying.

Mr. Hernandez recused (self-declared as ineligible to vote on the following Motion due to a possible or known conflict of interest [he is on the Holiday Parade Planning Committee and is a Chamber of Commerce Executive Member]) and left the room at this time, making nine Board Members present (the ANC quorum is nine). Mr. Gallo presided.

XI. <u>Motion/Discussion/Vote</u> on a possible Board action to participate in The 49th Annual Pacoima Holiday Parade on 12/10/16 in the amount not to exceed \$1000 for the entry cost, rental of vehicle and other supplies required for ANC's participation. Mr. Gallo explained event outreach. Board Members answered questions about procedures and funding.

**FUNDING MOTION** (by Ms. Shoemaker, seconded by Mr. Duran): The Arleta Neighborhood Council will participate in The 49th Annual Pacoima Holiday Parade on 12/10/16 in the amount not to exceed \$1,000 for the entry cost, rental of vehicle and other supplies required for ANC's participation.

**FUNDING MOTION PASSED** unanimously by a roll call vote of eight of the nine eligible voters present with all nine in favor ("Yes" or "Aye") (Barron, Duran, Gallon, Lacson, Lopez, Moreno, Nguyen and Shoemaker); zero opposed; zero abstained.

Mr. Hernandez returned to the room at this time, making ten Board Members present (the ANC quorum is nine).

XII. <u>Motion/Discussion/Vote</u> on a possible Board action to approve payment for Valley Alliance of Neighborhood Councils (VANC) for outreach and education events for NC's: Resource Board Planning Forum November 10, 2016 and VANC Mixer March 9, 2017 in the amount of \$500, check payable to JCS Catering Company.

**FUNDING MOTION** (by Mr. Gallo, seconded by Mr. Barron): The Arleta Neighborhood Council approves payment for Valley Alliance of Neighborhood Councils (VANC) for outreach and education events for NC's Resource Board Planning Forum November 10, 2016 and VANC Mixer March 9, 2017 in the amount of \$500, check payable to JCS Catering Company.

**DISCUSSION**: Mr. Hernandez explained VANC, the Forum, the Mixer and their value.

**FUNDING MOTION PASSED** unanimously by a roll call vote of nine of the ten eligible voters present with all nine in favor ("Yes" or "Aye") (Barron, Duran, Gallo, Gallon, Lacson, Lopez, Moreno, Nguyen and Shoemaker); zero opposed; zero abstained.

XIII. Motion/Discussion/Vote on a possible Board action to approve an increase of \$1.32 for a Minute taker. Current bill rate is \$23.10 and requesting new bill rate at \$24.42. This change will result in new compensation for Minute taker from \$17.50 to \$18.50.

**FUNDING MOTION** (by Mr. Gallo, seconded by Mr. Barron): The Arleta Neighborhood Council approves an increase of \$1.32 for a Minute taker. Current bill rate is \$23.10 and requesting new bill rate at \$24.42. This change will result in new compensation for Minute taker from \$17.50 to \$18.50.

**DISCUSSION**: Ms. Lacson explained that the person writing the Minutes had mistakenly been paid as an administrative assistant.

**FUNDING MOTION PASSED** unanimously by a roll call vote of nine of the ten eligible voters present with all nine in favor ("Yes" or "Aye") (Barron, Duran, Gallo,

Gallon, Lacson, Lopez, Moreno, Nguyen and Shoemaker); zero opposed; zero abstained.
