**Minutes of the Arleta Neighborhood Council  
General Board Meeting  
Tuesday, April 20, 2021**

**I. Call to Order:** President Raymond Duran called the meeting to order at 6:33 p.m.

The **Pledge of Allegiance** was led by Burton Hunter.

**President's Report:** President Raymond Duran spoke about the ANC elections and encouraged everyone to vote.

**III. General Public Comment –**

Lorena Bernal, **Council District 6**, thanked those from the ANC that participated in a recent clean-up. She gave an update on street lighting – wire theft is still a big problem. Slurry seal is continuing throughout Arleta as well as street resurfacing. Street humps will be installed on Beachy soon. There have been clean-ups at homeless encampments such as the ones at El Super and Reedley. Officer Ware is continuing to work on this. Lorena announced a listening session for the City Budget scheduled for Thursday and encouraged everyone to listen in and give suggestions. The vaccination center is back at Branford Park this week.

Michael Menjivar, L.A.U.S.D., stated that Kelly Gonez will be attending our meeting to give updates.

**DONE** representative, Mario Hernandez spoke about Conflict of Interest law and the importance of contacting the City Attorney's Office. Mr. Hernandez also gave an update on neighborhood council funding: May 20<sup>th</sup> is the last day to submit an event request. June 1<sup>st</sup> is the last day for check payment. June 20<sup>th</sup> is the last day to use the bank card. Neighborhood Councils are allowed to roll over up to \$10,000.00 to the next fiscal year.

Jessica Orellano, **Los Angeles County Supervisor's Office, District 3**, reported that the County has set aside vaccines for high COVID areas such as Pacoima and Arleta. **Motion 4/**Seconded/Carried – Gary Gallon – move to approve up to \$2,000.00 to purchase one Apple Computer for community impact statements and other Community Improvement/Land Use Committee needs. (Second by Mary Oberg). The motion passed unanimously.

**IX. Report from Budget Advocate** – Budget Advocate not present.

**LAUSD School Board, District 6** - Kelly Gonez gave updates regarding schools, staffing, and students returning to schools. All Elementary Schools and Early Education are back in school. Middle and High Schools will return next week. There have been many upgrades at our schools for safety and teachers and staff have been vaccinated. They have resumed athletics. Many school sites have been made available as vaccination sites for community members.

President Duran answered questions regarding neighborhood council elections and encouraged stakeholders to vote.

Several individuals stated that many stakeholders have had difficulty registering online; it has taken over two weeks to get a ballot once registered. It was noted that it was difficult for people that are not computer savvy to register and submit documentation online.
