# III. Report from L.A.P.D. Senior Lead Officer and Representatives from other State, County or City Agencies.

LAPD Arleta SLO - Tracy Ware Good Neighborhood Watch meeting last night...

Reported Clean-ups happened at Hoyt/Canterbury and behind Arleta Post Office. "Pepper-Ball" is something less-lethal that can be used for protection if you get caught in a violent or dangerous situation. (There is a Police version for officers. A civilian-accessible version can be purchased.)

ONC has consistently supported the LAPD Mission Division's kids / cadet / & PAL programs. Thank you. She presented the ANC Board President, Raymond Duran with a plaque in gratitude.

Kagel Canyon RV issue; Marcela with CD-6 is looking into this situation & will give a report.

Area Stakeholder – Lady on Beachy – she's staying on sidewalk – disruptive in area. suspect that she is under a restraining order from her mother's house nearby. SLO will look into it.

Call it in is you see a problem. Even if it says it's already been reported, follow-through with reporting it anyway. The more calls received on an issue, then the higher it gets bumped up the list for responding to it. If it is a mental issue that you are reporting, then call it in to the Non-Emergency Line; If it is a criminal issue situation, call the police detectives. Call 911 if it's something dangerous happening For encampment at Terra Bella & Wakefield – Tracy is working with Officer Smith.

For encampments at Tobias park – due to be cleaned out and temporarily closed during renovations.

## Marcela Quintanilla – with the CD-6 office of Imelda Padilla.

Tobias Park renovations will displace people, so expect to see homeless moving around.

Canterbury & Hoyt clean-up was supposed to be today (Tues.) but the Dept of Sanitation dropped the ball for a "today" schedule. (Will now be scheduled for Friday 6-21.

RV on Kagel Canyon & Canterbury (RV was Not leaking; no Dept. of Sanitation issues), so now they will follow the DOT rules for dealing with the vehicles.

Advertising a Grand Theft Auto event of Tuesday, July 9th.

Fiscal Budget is being prioritized, so turn in your requests for improvements needed in the area, so that the budget items can be prioritized and appropriate funding allocated in the District's Budget.

(examples: sidewalk repair, street repair, tree trimming, tree removal, or other items)

Street light repairs – to prevent further wire theft, will start encasing the bases in cement after repairs are made.

- Q.) Javad What is hold-up of Future Starbucks on Woodman? Marcela has offered to help. They need to resubmit a permit that was incorrectly filed.
- Q.) Jose P. The WELCOME TO ARLETA sign status. A.) Still being worked on. Funding to install the sign. Graffittee-Busters now has the sign. There may be some delay due to the project of installing sidewalks along the Woodman Corridor. Sign placement needs to fit in with the design of that project. Other comments from Loyce, Burton, Dave Hunt.

# Mayor's Office – Betsaira Aguilera – East Valley Rep, Mayor's Office of Community Engagement New Chief of Police Choice – she explained what the process will be for arriving at the appointment made to this crucial position. Comments about Bureau of Street Lights.

2 new programs to promote small business to be able to access resources that they need to move ahead. (mostly Under-Grad Students are being considered) Youth who may want to intern with the Mayor's Office. Strength United at local college/university (at CSUN?)

Q.) Ray Duran – 911 issue for wait times. Some improvement, then bad again.

Hiring freeze is for certain departments who have not used their funds to hire additional staff.

Comment) Community needs to see support from politicians in order to encourage people enough to consider applying for jobs with the City & government agencies.

Comment) \$ theft thresholds need to be lowered to be able to prosecute lawlessness. The 10-year "social experiment" is a failure in creating a safe society.

Robert Yaffe – "Ponzi scheme" of \$810 million tax revenue given out for housing homeless.

LASHA couldn't account for how or where this vast amount of money was spent.

Other comments from Geo. Dave Hunt –asked for clarity on process of how the new Chief of Police will be chosen.

# Report from Budget Advocates.

# Lionel Mares - Budget Advocate for Region 1.

Lionel reported that he was re-elected as Budget Advocate (BA). Elena from Panorama City NC was also elected. (Kevin Davis did not run for Budget Advocate this time.)

After Pandemic freezes were lifted on raising sewer charges, the City is accepting public comment on upgrading the infrastructure for sewer handling. expect rates to increase significantly.

Budget Advocates (BA) noted that there is a personnel issue in City services. They asked the City to <u>fill</u> the vacancies; <u>not</u> to <u>cut</u> positions.

24-0600 is the Mayor's Budget.

Kay Hartman has stepped-down for the Co-Chair seat of the Budget Advocates)

(unlimited) roll-over funds has been granted to NC's for their budgets into the next fiscal year.

The new DONE GM, Carmen Chang was at Budget Day (this past Saturday) and also attended the two most-recent Board of Neighborhood Commissioners (BONC) meetings.

IV. General Public Comments on Items <u>Not</u> Listed on Agenda - California State Law (the Brown Act) requires PUBLIC COMMENT to be a NON-DISCUSSION PERIOD (Two minutes /per Speaker).

The LA City Council passed supporting a Charter Reform Commission for schools. Expect to see a ballot measure for reform during this coming election.

	Christianna Hartwell resigned her <b>Renter</b> seat position in order to apply for the <b>Animal Welfare Seat</b> .
	B.) Vote to fill the <b>Animal Welfare Seat</b> with <b>Christianna Hartwell.</b> (Christianna Hartwell is ineligible to vote on this, as she has stepped down from her seat and so is technically not on the board for this vote.  Discussion: - She has 2 dogs registered with the City of Los Angeles. She is interested in the welfare of all animals in our community and is wanting to be sure that the City Departments are doing their part by implementing measures to insure that good standards are being upheld for these domestic animals. Also that they are taking reasonable measures to insure that the problems of predatory animals encroaching into our urban areas are being properly addressed.

	Stakeholder, <b>Stelian Martinez</b> applied to become part of this Board in the <b>At Large Seat</b> . Discussion: Stelian stated his long-time connection with the Arleta Community. He grew up in his family home just a few blocks from this location. His mother still lives there. He played sports at Branford Park and now has his oldest child enrolled in a sports program there. He and his wife Amy and their 3 children regularly attend Osborne Neighborhood Church (in Arleta) and both he and his eldest son are involved with the music ministry team at the church. He has a desire to work with others to create and maintain an Arleta community where his family and other families can thrive.
