# Minutes of the **ARLETA NEIGHBORHOOD COUNCIL (ANC)**

General Meeting of the Board and Elections Adhoc Committee Tuesday, September 10<sup>th</sup>, 2013 Beachy Elementary School, 9757 Beachy Ave., Arleta

### 1. Call to Order, Roll Call, Pledge of Allegiance and introductions.

President Sergio Ibarra called the Meeting to order at 6:42 p.m. Roll call was taken by minute taker Irving Sandoval. Pledge of allegiance was led by board President Sergio Ibarra

### 2. <u>President's Message (2 minutes)</u>

President Ibarra thanked those who attended the swearing in ceremony of Council Member Nury Martinez. He spoke on the turmoil in Syria and mentioned he spoke with Congress Member Tony Cardenas. He encouraged everyone to call the Cardenas office and express their thoughts on a looming war in Syria

### 3. <u>General Public Comments on items not listed on today's agenda (2 min per speaker)</u>

Margaret Shoemaker, Max Foster, Dianne Hand were part of a complaint committee to help address a complaint filed by Mr. Guy Dionne. They took turns reading a statement. "A complaint committee was created at the May 28, 2013 ANC board meeting. The committee has been waiting for the Arleta Neighborhood Council and/or Empower L.A. to supply the necessary information to complete the task that was assigned...The committee has finalized its report and at the Executive Committee Meeting dated August 5, 2013 requested time on the agenda for the next meeting of the ANC board to report our findings. We find that our request has been denied since there is no time allowed on the agenda for us to give our report on this serious matter. This committee cannot be relieved of its duties until we are allowed to complete our task." The final report has been forwarded to Gracie Liu, the General Manager of Empower LA

**Speaker:** <u>Luis E. Sencion</u>- Arleta High School Leadership, He announced the first Arleta Football game will take place on September 20th and he hope people can come out and attend.

Speaker: Ernie Moscoso - President, North Hollywood Northeast Neighborhood

Council. Co-sponsoring the Repower LA event with the LADWP. This event is happening on October 5 at Pacoima City Hall from 9am to 1pm. In attendance will be Nury Martinez, Felipe Fuentes among other elected officials. This event will help DWP customers lower their energy bills.

**Speaker:** <u>Jack Lindblad</u> - Announced he is interested in filing papers for a state senate seat

### 5. <u>Committee reports from Outreach, Improvement, and budget (5 min per speaker)</u>

Report from Community Improvement Committee chair Jack Lindblad. He is catching up on CIC reports because there haven't many general meetings. He recalled some of the achievements in his time as CIC chair. One of these achievements being the selection of the bidders in the selection of the Arleta sign. In the June meeting there was discussion on the Tujunga spreading grounds. "We are very successful in getting conveyance over truck trips."He added that light rail will happen. The board granted Jack Lindblad an extra two minutes to complete his report. In his extra time he added another accomplishment of the CIC is to help Metro decide to build light rail along Van Nuys. Time was up before he could finish talking about the sign **Public comment:** Joy Bizar wants to know what is going on with the sign Sergio Ibarra assured her there will be more about the sign in future meetings. **Public comment:** Guy Dionne - Requested the board speak on item 17 before anything else

### 6. <u>Presentation and briefing from the Department of Neighborhood Empowerment,</u> <u>Melvin Cañas (10 min)</u>

Melvin Cañas talked about the upcoming Congress of Neighborhood Councils event happening on September 28, 2013. It's free and open to the public. New board members are strongly encouraged to attend.

**Public comment:** <u>Guy Dionne</u> - Asked about the status of the complaint he filed about six months ago. The complaints are sent to the city attorney's office so they can see if there is any merit to them. It's been a busy time at D.O.N.E with new staff coming in and elections coming up.

**Public comment:** <u>Margaret Shoemaker</u> - The Grievance committee has not been able to report their findings.

**Board Member comment:** <u>Jack Lindblad</u> - asked if these reports are being taken seriously.

James Kallas asked why the president couldn't agendize the item even after the Grievance committee went to the executive committee meetings and ask the report be agendized. He urged D.O.N.E to open an investigation and look into why the complaints are not being handled at the D.O.N.E level.

Sergio Ibarra said the complaints was received by the board and acknowledged. The board has been consulting with the department and the city attorney. Every single member is responsible for resolving the issues. He hopes all board members can attend the Arleta NC board member training on September 24.

There were 3 candidates for the Youth Member position Maria Mejia, Daniel Orozco, Luis E. Sencion All 3 talked about themselves and discussed some of their qualifications. Each member had one vote for one of the 3 candidates. With 11 members a candidate who receives 6 or more votes would be the winner. Luis Sencion receives 8 out of 11 votes. Luis Sencion is the new Youth Representative.

Maria Mejia, Daniel Orozco, Max foster are candidates for At -Large Representative. Max Foster receives 7 out of 12 votes. Max Foster is the New At-Large Representative.

Maria Mejia, Daniel Orozco are candidates for Youth Group Representative. Daniel Orozco receives 10 out of 13 votes. Daniel Orozco is the new Youth Group Rep.

14. Discussion and possible action on complaint filed with the Arleta Neighborhood Council by Ms. Joy Bizar on June 18, 2013. Article XI, Section C of the ANC bylaws deems that the complaint be acknowledge, and that the board from an ad-hoc grievance committee populated by three randomly selected stakeholders from a pool of names to investigate and make a recommendation to the board on their findings. Article VII, Section III grants the president of the ANC the authority to appoint all committee chairpersons with majority vote of the board (10 min)
