**On Committees**

Board members who are not in committees but attend committee meetings must not inadvertently participate in a meeting.

James Kallas asked how can he introduce a suggestion to a committee if he has to stay quiet at the meetings. Melvin suggested he present his suggestion to the committee chair or present it to the board to send it to committee. A one man committee is acceptable.

**Potential Conflict of Interest**

Anyone that may have a conflict of interest will need to recuse themselves from the item discussion and seek advice from the city attorney.

**On the Brown Act**

The Brown Act is about giving notice to the people. It Deals with how meetings are conducted. Instructs on how to post meeting notices. Informs on how to constitute a meeting. All meetings are public. Violation of the Brown Act can result in criminal civil penalties.
