7. Committee reports from Outreach, Improvement and Budget, and Adhoc Public Safety Committee, Adhoc Bylaws Committee

<u>Community Improvement report from Julian Ramirez</u>, He is proud to say that more new people attend his meetings. He printed out 50 flyers for the online survey for stakeholders to take. The sidewalks have been neglected for years. It's important stakeholders work together to make change

happen.

<u>Community Outreach report from Saul Perez</u>, He is not aware of any projects that outreach had planned. It's too late for the committee to accept recommendations for Christmas. He can begin to take recommendations for early 2015. He has yet to establish a meeting location.

Adhoc Bylaws Committee update from John Hernandez, He is still working on getting a location for the bylaws study session.

<u>Budget Committee report from Kelly Magallanes</u>, The committee will meet and readjust the budget set aside for Halloween Harvest and Veteran's Breakfast since they didn't take place. She noted that committee meetings can't be held on Wednesdays or Weekends.

Faviola Saucedo enters the meeting at 7:08pm. 12 members present.

8. Report from Public Safety Departments from L.A.P.D Senior Lead Officer Lee Perry or any LAFD representatives. Updates from any other government officials (Congressman Cardenas' Office, State Senator Alex Padilla's Office, Assemblyman Bocanegra's Office, Lorena Bernal, Councilmember Nury Martinez' Office, Representative from Monica Ratliff's Office, Or any other City Departments.

<u>Officer Lee Perry</u>, Crime is down 9% from last year. There have been two shootings, one is gang related. The victims are not cooperating. There is an increase in homelessness but they are waiting for the Armory to open. There is an increase in gang graffiti. Some gangs are cleaning up their own graffiti because they don't want pressure from LAPD. Now that prop 47 passed all misdemeanor criminals will be released on January 1st and it will be a situation. Misdemeanor criminals will not be on parole. With Christmas coming soon beware of people stealing packages from front yards. If you are expecting a package have a neighbor receive it for you or request that the delivery person require a signature to receive the package.

Jenny Rayas, Congressman Tony Cardenas, She mentioned the Veterans Day parade was a success, The affordable care act sign-up period has begun. The congressman will be hosting an Affordable Care Act Workshop on Saturday, November 29 at Lake View Terrace Branch Library 12002 Osborne St, Sylmar, CA 91342 from 10am-2pm. Lastly she announced the office is moving to a new location. 8134 Van Nuys Blvd., Suite 206 Panorama City, CA 91402 Lorena Bernal, Councilwoman Nury Martinez, She announced a Covered California Workshop will take place Saturday, November 22 at Branford Park from 10am-2pm. The Healthcare department will be at the event and there will be entertainment for the kids. Walgreens will be giving free flu shots. The council woman is hosting her first Love of Reading Book Drive. Drop off new or gently used books in bins located in her Sun Valley and Van Nuys offices. The books will then be given to the LAPD to help build their LAPD Little Free Libraries. Lydia Grant, City Commissioner North Valley, There is a proposal to create a grievance panel to handle grievances. The neighborhood council can follow what is in the bylaws until the grievance panel is set up. The code of conduct being pushed by the department essentially means don't discriminate and treat others the way you want to be treated. This helps protect the public and give respect to board members. The department wants an online system to keep track of all the documents submitted by the neighborhood councils. She pointed out that each agenda include

the 1 posting location where agendas will be posted 24 hours before the meetings. She also mentioned a policy coming soon that will detail what needs to go on a neighborhood councils website. Lastly she spoke on how commissioners hope to help make outreach easier by creating a template for outreach that will give them ideas on things they can do.
