



Minutes of the  
**ARLETA NEIGHBORHOOD COUNCIL (ANC)**  
**GENERAL SPECIAL BOARD MEETING**  
**Thursday, June 25, 2015**

The meeting was called to order at 7:04 p.m. by President John Hernandez.

The Pledge of Allegiance was recited.

9 Board Members present. The board has reached a quorum.

Sergio Ibarra arrived at 8:24 p.m. 10 Board Members present.

**Vacant Board Positions:**

President John Hernandez announced that there are two open board positions:

- a. At Large Seat (1) and
- b. Business Seat (1)

There were two stakeholders present that showed an interest in becoming board members, Jon Barnes and Tim Gallo. They will receive applications.

A stakeholder asked if there has been any posting in the community to announce the open board positions. The president responded that yes, there have been agendas posted with the open board positions listed as possible board action.

**Appointments to Committees:**

President John Hernandez asked if there were any board members or stakeholders interested in serving on the Budget Committee (1 Board Member and/or up to 2 Stakeholders) or the Outreach Committee (1 Board Member and/or up to 3 Stakeholders).

**Budget Representative Appointment:**

President Hernandez asked if there was anyone interested in being the City of Los Angeles Budget Representative for 2015-2016. This position can be filled by a board member or a stakeholder. There is a half day event this Saturday. There were no volunteers.

M1/2/C - Veronica de Lara - move that the ANC participate and fund National Night Out to be held at Branford Park on August 4, 2015 for \$5,000.00. (Second by Saul Perez).

Vote result: 9 Yes, 0 No, 0 abstentions

A stakeholder asked what the \$5,000.00 is to be spent on. Some examples of expenses included approximately \$1,100.00 for Pastora Jump and expense for food (possibly In n Out hamburgers). It was requested that more detail be given when funding projects.
