I. Call to Order and Pledge of Allegiance.

President John Hernandez called the Discussion to order at 6:42 p.m. The Pledge of Allegiance was led by Alex Davis, Valley Industry & Commerce Association (VICA).

Roll Call was taken by Notes Writer. Eight of the nine Board Members were present at the Roll Call, which is not a quorum: Olivia Chavez, Raymond Duran, Jaime Gallo, John Hernandez, Loyce Lacson, Kelly Magallanes, Bryan Ramirez and Margaret Shoemaker. Jesus Barron and Danna Gutierrez were absent (unexcused). The ANC quorum (the minimum number of Board Members needing to be present to take binding votes on Agendized Items) is nine (see http://www.ArletaNC.org/wp-content/uploads/2014/03/ANC-Bylaws-Amendments-012614SD.pdf), so at this time the Board could only take public comments and could not have any official discussions, and could not make any Motions or take any votes. Nine of the 17 Board Seats were filled (by election or appointment). Eight Board Seats (Business, Home/Condo Owner (2), Renters (2), Seniors (2) and Youth) were vacant.
