Council District 6 is working on having a Health Fair in November in collaboration with Walgreens and Congressman Cardenas.

Report from L.A.P.D. Senior Lead Officer:

Senior Lead Officer, Tracy Ware distributed current crime maps. She reported that crime is increasing in Arleta. Grand Theft Auto (GTA) has gone up from 44 to 53. Most GTAs are happening in the early morning hours, between 12 a.m. and 6 a.m. Our commanding officer is still going with the "Lock it, Hide it, Keep it" campaign. Officer Ware reported on a couple of problem locations she has been working on. She asked that stakeholders let her know when they see illegal vendors so she can continue to warn and cite them. The Branford Park Neighborhood Watch meeting will be held on Tuesday, September 20, 2016 at 6:30 p.m. at 13306 Branford St. at the Branford Park Recreation Center-Child-Care Center.

The L.A.P.D. Mission Area is hosting a "Safe and Sober Driving Awareness Seminar" on Thursday, September 22, 2016 at the L.A.P.D. Davis Academy Bomb Squad Room 12001 Blucher Ave. Granada Hills. CA 91340.

There will be a 5K coming up in October. She will send flyers via e-mail. Officer Ware answered questions about crime, problems with homeless encampments, and the ACE program. L.A.P.D Mission Station will be utilizing the ACE program.
