- III. Report from L.A.P.D. Senior Lead Officer and Fire Dept.

Senior Lead Officer **Tracy Ware** gave an update regarding homeless at Woodman & Osborne: This is private property, so it has to be handled differently than encampments on City property. (but it IS being dealt with.) These people are <u>not</u> accepting housing (as is the case with many people in encampments). A shooting incident occurred near Branford Park. No one was hit. Vehicles: Some reported stolen cars were recovered; Some not stolen from this area. Stolen cars are apparently being "dumped" in our area. Chevy trucks and Toyotas are still #1 targets for theft. These are mostly occurring during the 12 pm – 11:59 pm watch hours.

A meeting on Saturday, June 14th, at the Jewish Temple on Roscoe. A swath of home break-ins have occurred in that vicinity, so neighbors what to know how best to handle the situations when they arise and what precautions to take.

Scott Hilton – from nearby Fire station. Annual Brush enforcement teams are going out and advising properties about clearance requirements for better fire control.

Fire Dept. is switching to an automated vehicle location system to answer emergency calls (using the nearest available trucks, not just the ones in the assigned district.)

- Q. **Loyce Lacson** Is Fire Dept using drones. A. Some, but limited battery life generally keeps them on the ground until some kind of incident is reported.
- Q.. Jaime Gallo, Christianna Hartwell Strategies, Jose Pumay Roofs on many houses are vulnerable. Jesse Ramos, Christianna, Loyce- Could we ask that High Schools be refused permits for fireworks at graduation ceremonies? (graduation comes at a vulnerable fire-season time of the year.). Call 911 for reporting back yard fires / trash burning. "Geo"- suggest occasional firehouse open-house. Burt What's the possibility of 3-point-of reference camera systems be installed to spot fires and illegal fireworks?

Jaime Gallo – With World Cup & Olympics coming up, how can we make this work with cut-back in services? **Joanne Gallon, Christianna Hartwell** – Animal services cuts: terrible budget management **Burton Hunte**r – Budget Advocates submitted very practical budget solutions prior to this budget being settled on. Were they paid heed to??

• Voting for ANC Board Elections – has now closed. Preliminary results will be posted sometime tonight; but final results will not be posted until May 28th. :

• Other announcements –

Loyce L – At LAPD Golf Tournament – Arleta was thanked for our continued support for functions that the City budget does NOT cover. **Loyce & Joann G** – \$300 fine for driving in bus lanes (cameras catch you and photo accompanies the citation that is mailed to you.) and now Speed traffic cameras. Burton H- comments regarding new Daylight Parking Laws (flier on table). Plus other comments brought up at LANCC & VANC meetings:

• Glenn Bailey was at the NC Homelessness Liaison meeting. Very few NC's had representatives listed. Each NC is allowed up to 4 liaisons to this group. Each NC should have representatives "listed" in that group (at the very least); even if they don't attend meetings. Those representatives can then have information and updates sent to them (to stay up-to-date on where things are with the City). These reps. can then also submit recommendations to that group on behalf of our Board.

[&]quot;Budget Day" at downtown City Hall – Registration for this event begins tomorrow (May 21st). "Congress of Neighborhoods" is a separate event held at City Hall. This is now only in the planning stages.

• Regarding **AB 411** updates (pertinent to holding **NC's meeting Virtually**)

AB 467 AB 2449 Problems with the wordings in those bills is that they still subject NC's to restrictions. Members must be located within the City Limits of LA at the time of the meeting in order to qualify to participate virtually. (If they are outside,, then they have to comply with AB 2449).

Also, according to **AB 2449** an individual Board member can only participate virtually 2 times /per year. That bill also limits the reasons for <u>not</u> attending the meeting in person.

(Commissioner Len Schaffer commented that what he thinks might be the <u>worst</u> part of this bill is that it puts NC's in that category of government so that we must conform to section 54953 of the Government Code (This is what will kill us.)

• IF we are considering opting-in to ask the City for a **ZOOM License** through them (\$200 /per year) plan ahead and opt into it _ (at the beginning of the NC Budget cycle).

This ZOOM license comes with recordings retained for as long as you hold onto the license.

(Each committee that might meet virtually would need a separate ZOOM license).

A Free ZOOM account is only good for holding a 40 minute meeting.

A paid Individual ZOOM account only gets 1 hour of cloud storage...
