Dave Hunt (as an individual) gave a Legislative Update. **SB-495, SB-79**, Developers being given leeway to go into fire-burn areas and buy up properties in anticipation of special dispensation to override current zoning regulations for their constructions..

AB-727 is now on the Governor’s desk – mandates that public and private schools serving students in grades 7-12 and public and private higher education institutions print the contact information for The Trevor Project, an LGBTQ+ counseling and suicide prevention hotline, on student ID cards, starting July 1, 2026

AB-84 is currently inactive; regarding state having more control over Charter & Private schools.

Proposition 50 on ballot. Be very careful how you vote on this. Some of the advertising is deceptive.

Discussion: **Jesse Ramos** -This reflects that this is before the Budget adjustment.

- III. Discussion and possible recommendations to the ANC Board regarding a Community Impact Statement on **Council File 25-0642** -Relative to the elimination of parking (off-street) requirements in certain new developments.
 Motioned by – Dave Hunt 2nd by – Burton Hunter
 The Motion Passed with 7 yes, 0 no, 2 ineligible, 2 absent, 0 abstained
- Discussion: **Jesse Ramos** This bill removes parking space requirements in new developments around transit hubs. Still see mass congestion in N.Y. & in other transit-heavy cities across the country. Angelinos won't be giving up their automobiles **(SB-79)**
Albert G., Raymond, Robert Yaffe, Dave Hunt. Jesse R, Loyce L., Ray – Already there are “parking wars” for any available parking spaces. *(implying that this will only make it worse.)* **Gary Gallon. Burt** – if this also covers commercial? Yes, this is also covered; parking not needed for commercial spaces. **Albert G.**
- IV. Possible Motion/Discussion/Vote on approval to amend the 2025-2026 ANC Budget
 (At our Board meeting, a copy is available to view at the check-in table.)
 Motioned by – Burton Hunter 2nd by – Dave Hunt
 The Motion Passed with 7 yes, 0 no, 2 ineligible, 2 absent, 0 abstained
- Discussion: **Jesse Ramos** - \$8,230.38 was rolled-over into ANC account from previous year balance. ANC's New Balance is \$33,230.38. This added amount will be designated into a couple of different ANC categories for budgeted spending. **Dave Hunt** – Did the City finally decide that NC's are stuck with the rolled-back \$25 K allotment for this calendar year? The answer is **Yes**. **Jesse** – gave history of declining NC funding & roll-backs. **Loyce Lacson** Again, the City doesn't want to listen to Neighborhood Councils (NC's). However the NC's were established city-wide into the Los Angeles City Charter just because the San Fernando Valley was considering secession from the City of L.A., (because taxes were flowing out of the Valley, but no consideration of services being rendered back to the Valley.) We weren't being heard.
- V. A **“Faith and Blue”** gathering, honoring our police officers as 1st Responders will be held at Osborne Neighborhood Church (this church) on **Monday, October 13th at 5:30 pm.**
 • Possible Motion/Discussion/Vote to spend **up to \$1,000.** for purchasing ANC-Logo-marked gifts to give to our community's First Responders at this event and as outreach items at future events.

 The Motion Passed with 7 yes, 0 no, 2 ineligible, 2 absent, 0 abstained
- Discussion: **Burt, Dave Hunt** – a gesture to the police, saying that “We support you.”, **Robert Yaffe** – We're supporting the police, but in-turn the police should be supporting and promoting us. **Loyce Lacson.** – Possibly raise the amount for outreach materials. This won't buy very much **Ray Duran** – We have enough other materials, just want a few other particular things to be able to give out. **Irene** – is this “Faith and Blue” event only for the police? Or does it include other 1st Responders? **Ray** Yes, let's support our “Men in Blue”. Other events are including honoring other groups as well. Encourage you to go to local CPAB meetings. **Loyce** – CPAB can also be attended live-streamed. **Dave Hunt** – Go to gatherings and meet them. **Ray** – Looking to be able to give-out some nice items with ANC's logo clearly visible.

 The Motion Passed with 7 yes, 0 no, 2 ineligible, 2 absent, 0 abstained
- Discussion: **Loyce** – doesn't think that \$300 is enough. **Ray & Jesse** We spent about that much last year with leftovers that were then donated.

The Motion **Passed** with 7 yes, 0 no, 2 ineligible, 2 absent, 0 abstained

Discussion: **Ray** has seen a lot of kids go through these programs and get a lot of help and emotional support as they grow. **Loyce L.** – Benefits the kids and the Cadet programs. Cadets get help all the time; even tutoring. In turn, they GET help all the time. **Jesse Ramos** – (This was done as a single vote – instead of 2)

Ray, Loyce, Burt -Was suggested a cotton fabric T-shirt or possibly a hat with ANC logo when wearing “civilian clothes”.
