Marcella Quintanilla –Arleta Rep. from CD-6, 11/21 Turkey and food give away NH Foundation on Fri 11-21st starting at 9 am as long as supplies last. Thursday 11-20 Van Nuys at a Church on the Way, at Sherman Way & Tyrone. Nov 26 in San Fernando. Advertising fliers are available on table.

Jesse R. - CF 25-0843 regarding RV parks. No public input prior starting development. Public comment: These are for transients, Yes? This is being pushed ahead without any input from the public. Likely to negatively affect property values. (rumor has it that) Sun Valley possibly has one. Marcella- Tiny homes on the Metro parking lot in Sun Valley. This will be happening. Q. Longevity of this project? Will these become "forever" installations? A. It's a lease from METRO. Tiny homes qualify for the quota necessary for creating space for unhoused in our district in order to allow officials to force homeless off the streets. Q. Other areas of the city are pushing their homeless into our area; so these temporary gestures will Never end.

Jaime Gallo - If this is to happen in Arleta, we would like to first have our voices heard. This is an "invasion" by the City of LA upon us. **Marcella** – she will let us know if she hears of <u>any</u>thing coming into our area.

Dave Hunt – **regarding:** Mission Hills RV parking. No one had any idea about this. Not until a local realtor put out the info concerning a meeting to be held about this. This lot is as yet totally undeveloped. The land has just been scraped to clear to. No utilities installed. Is City going to pay the \$75 /per unit /per night to park in this undeveloped lot? This is only blocks away from a couple of schools. These kind of rash gestures are unacceptable. If they get away with it, where in Arleta will it happen? **Loyce** – Governor said that we can force the homeless off the street. But our City is NOT making the effort.

Robert Yaffe – Our Mayor is not doing her job.

Jaime G. - Our Mayor spoke against our California State Governor's instructions.

Robert Yaffe –(**Another issue**) When will building start for the development in P.C. where Montgomery Wards once was? When in, it will certainly bring up property values. **Marcella** - Walmart will be moving their P.C. location into this new development <u>after</u> the new construction is completed [making way for a planned new construction at the shopping mall area at their current site.]
